Town and Country Planning (Control of Advertisements)
Regulations 1960

The County of Devon (North and East Devon Area of Special
Control of Advertisements) Order 1964

WHEREAS

(1) The County Council of the Administrative County of Devon (hereinafter called "the Council") as Local Planning Authority have considered whether any part of the said County should be defined as an area of special control in accordance with Regulation 10 of the Town and Country Planning (Control of Advertisements) Regulations 1960.

(2) The Council have decided that all those parts of the County specified in the First Schedule hereto but excluding the areas specified in the Second schedule hereto should be defined as such an area.

NOW THEREFORE the Council in pursuance of the powers conferred upon them by Section 34 of the Town and Country Planning Act 1962 and the said regulation 10

DO HEREBY ORDER

1. That all those parts of the County specified in the First Schedule hereto and shown on the map lettered "A" annexed hereto within a black line and hatched with black stipple but excluding the areas specified in the Second Schedule hereto shall be defined as an area of Special Control for the purpose of the said regulations
2. That this Order may be cited as The County of Devon (North and East Devon Area of Special Control of Advertisements) Order 1964

THE FIRST SCHEDULE

1. The Boroughs of Barnstaple, Bideford, Great Torrington, Honiton, Okehampton, South Molton and Tiverton
2. The Urban Districts of Budleigh Salterton, Crediton, Exmouth, Ilfracombe, Lynton, Northam, Ottery St. Mary, Seaton and Sidmouth
3. The Rural Districts of Axminster, Barnstaple, Bideford, Broadwoodwidge, Holsworthy, Honiton, South Molton, Tiverton and Torrington
4. Those parts of the Rural Districts of Crediton, Okehampton, and St. Thomas which lie outside the Dartmoor National Park
