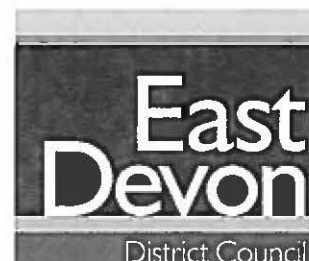

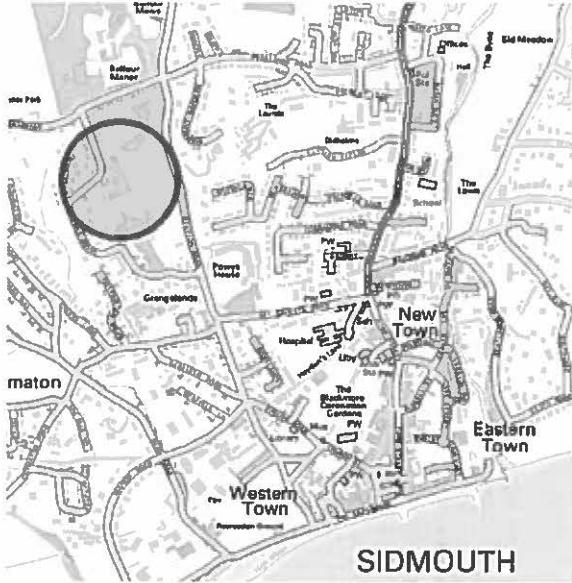

Members please note:

- You must declare any personal or prejudicial interests in an item whenever it becomes apparent that you have an interest in the business being considered.
- Make sure you say the reason for your interest as this has to be included in the minutes.
- If your interest is prejudicial you must leave the room unless you have obtained a dispensation from the Council's Standards Committee or where Para 12(2) of the Code can be applied. Para 12(2) allows a Member with a prejudicial interest to stay for the purpose of making representations, answering questions or giving evidence relating to the business but only at meetings where the public are also allowed to make representations. If you do remain, you must not exercise decision-making functions or seek to improperly influence the decision; you must leave the meeting room once you have made your representation.
- You also need to declare when you are subject to the party whip before the matter is discussed.

Getting to the Meeting – for the benefit of visitors



The entrance to the Council Offices is located on Station Road, Sidmouth. **Parking** is limited during normal working hours but normally easily available for evening meetings.

The following **bus service** stops outside the Council Offices on Station Road:

From Exmouth, Budleigh, Otterton and Newton Poppleford – 157

The following buses all terminate at the Triangle in Sidmouth, From the Triangle, walk up Station Road until you reach the Council Offices (approximately ½ mile).

From Exeter – 52A, 52B

From Honiton – 340 (Railway Station), 387 (Town Centre)

From Seaton – 52A, 899

From Ottery St Mary – 382, 387

***1 Minutes**

The minutes of the meeting of the Planning Inspections Committee held on 15 May 2009 were confirmed and signed as a true record.

***2 Application referred to the Planning Inspections Committee**

(Councillor Paul Diviani declared a personal interest in this site as Chairman of the Blackdown Hills Area of Outstanding Natural Beauty).

The Committee considered the application and matter referred to it by the Development Management Committee. Members of the Planning Inspections Committee along with the Principal Planning Officer, Senior Development Management Officer, Enforcement Officer, Enforcement Administration Assistant and Democratic Services Support Officer had informally visited the site earlier that day.

The following decision was made having taken into account the report previously submitted to the Development Management Committee which had been brought to Members' attention, noted by them and updated during the site visit.

- (a) Otterhead: Application No: 08/1195/FUL – Proposed expansion of workshop and machinery storage buildings at Broadhayes Farm, Stockland for Mr R Bright.

RESOLVED: that the application be REFUSED for the following reasons:

Reasons for Refusal

Application referred to the Planning Inspections Committee (con'd)

(a) Otterhead: Application No: 08/1195/FUL – Proposed expansion of workshop and machinery storage buildings at Broadhayes Farm, Stockland for Mr R Bright.

- 1 The site lies within an area designated as an Area of Outstanding Natural Beauty and the proposal would be contrary to the policy for such areas as defined by the County Structure Plan in Policy CDE3 and Local Plan Policy EN1 by reason of the mass, scale and height of the building as proposed resulting in a damaging effect upon the character and appearance of this designated landscape.
- 2 The proposal is accessed from an unclassified road in very close proximity to its junction with the C3O1 classified county road and the site access as limited visibility from and of emerging vehicles as does the highway junction and any increase in use and in consequence of this access and of the approach roads would result in danger and inconvenience to users of the highway contrary to East Devon Local Plan Policy TA7 (Adequacy of Road Network and Site Access).

The Committee asked that Enforcement Officers investigate the Broadhayes stone business operating on the site.
