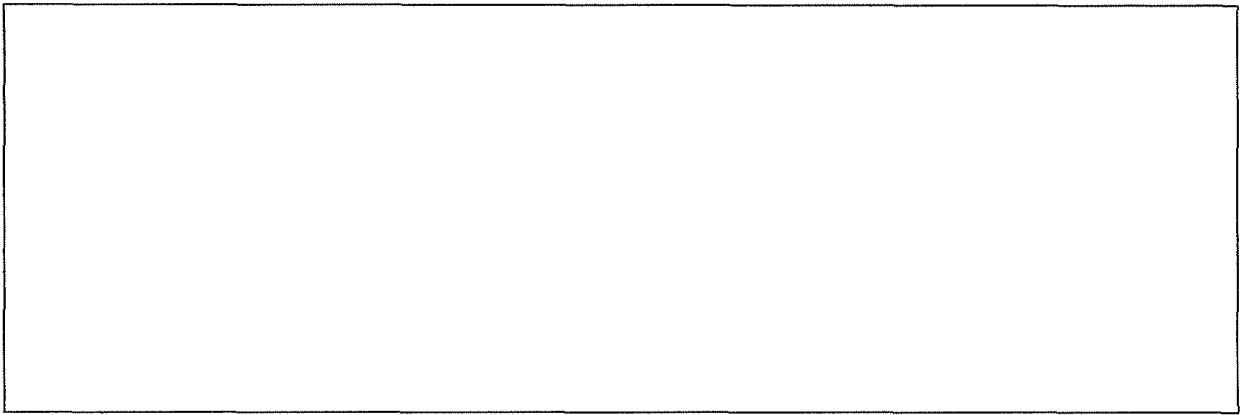

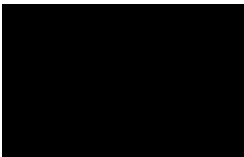
DECLARATION
