Not later than one month after the service of this notice you may appeal to the Secretary of State for Transport at

and the Secretary may substitute a smaller sum to that specified in this notice

The sum demanded will go to discharge any liability for private street works charges under the Code of 1980 but if when street works are carried out the cost is greater than this sum the balance must be paid by the owner at that time, conversely, if the cost is less at that time the County Council will refund the balance to the then owner

If any work is done in or for the purpose of erecting the building or buildings before payment has been made or secured to the satisfaction of the County Council in accordance with this notice, the owner of the land, and if he is a different person, the person undertaking the erection of the building or buildings, will be liable on summary conviction to a fine not exceeding level 3 on the standard scale and may on summary conviction be punished accordingly

The sum deposited will be repaid plus interest at the statutory rate when the street works have been satisfactorily completed, inspected by the Highway Authority and when a one year defects liability period has expired, there being no defects outstanding at the end of this period

Any payment made in respect of this notice, or correspondence relating to the security to be given for the sum demanded should be sent to the County Solicitor, County Hall, Topsham Road, Exeter EX2 4QD quoting the APC reference on the front of this letter
