The considerations of advancing this proposed Action are pertinent, since the Action may have implications for local businesses and for potential future development that need to be considered and addressed. Bourne Leisure has raised this concern previously and no changes to the proposed Action have been made. The Company considers that the proposed amendment is still necessary. Without the amendment the Action could result in an adverse effect on sustainable development, where any of the outputs conflicted with the NP and Local Plan's growth strategy, in conflict with basic condition d (Neighbourhood Planning Guidance, ID: 41-065) that the examiner will consider.
