The Submission Version Draft NP states at paragraph 5:
“Calls have been made, following initial consultations, for full Environmental Impact Assessments (EIA) to be carried out on all appropriate future developments.”

Additionally, it states at paragraph 19 (previously paragraph 18):
“To help achieve net gains as well as protect existing biodiversity within the town’s built-up area, the suggestion has been made that planning applications for new development should in future undertake a full Environmental Impact Assessment.”

Bourne Leisure has previously noted that EIA procedures are governed by national regulations (implementing EU directives), and are not a responsibility for development plan policy to deliver. The NP currently calls for a full EIA to be carried out on “*all appropriate*” development or “*new*” development. Bourne Leisure therefore re-states their previous objection to the unsuitability of the NP making comment on the need for EIA.

The submission of reports considering the various environmental and other impacts of the development may be necessary in accordance with statutory, or the Council’s validation requirements. However, these documents would not necessarily comprise a full EIA.
