PROPOSED MODIFICATION 2000

WHEREAS

- (1) The East Devon District Council (hereinafter called "the Council") as Local Planning Authority have considered whether the County of Devon (North and East Devon Area of Special Control of Advertisements) Order should be modified in respect of land at Ottery St Mary in accordance with Regulation 18 of the Town and Country Planning (Control of Advertisements) Regulations 1992.
- (2) The Council have decided that part of Ottery St Mary town centre specified in the Schedule hereto should be removed from the area.

NOW THEREFORE the Council in pursuance of the powers conferred upon them by Section 220 of the Town and Country Planning Act 1990 and the said regulation 18.

DO HEREBY ORDER


- 1 That all those parts of Ottery St Mary specified in the Schedule hereto and shown on the map lettered "A" annexed hereto in black hatching shall be removed from the Area of Special Control for the purpose of the said regulations.
- 2 That this Order may be cited as The County of Devon (North and East Devon Area of Special Control of Advertisements) Modification Order 2000.

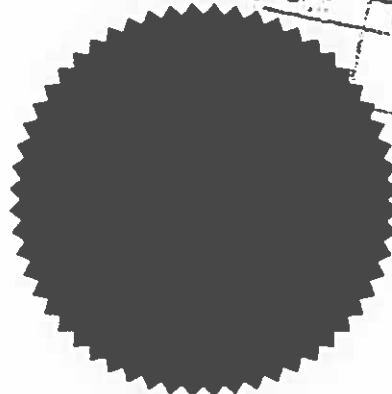

THE SCHEDULE

- 1 Land within Ottery St Mary town centre indicated in the East Devon District Local Plan Deposit Version (1997) as the town shopping area but excluding land in the vicinity of Gold Street as indicated on the attached map.
- 2 The land is defined as the whole of Broad Street (excluding Marist Convent School), the western end of Jesu Street including numbers 1, 3, 5, 7, 9 and 11 and the school (north side) and numbers 2, 4, 6, 8, 10, 12 and 14 (south side), numbers 1 and 3 Tip Hill, the eastern end of Mill Street, including numbers 1-37 (south side) and 2-30 (north side), the south side of Hind Street east of Fouraze, numbers 1 and 2 Prospect Place and numbers 1, 3, 5, 7, 9, and 11 (west side) and numbers 2, 4 and 6 (east side) of Silver Street.
