Obtaining your personal information

Information about you, as the dog owner or keeper may have been provided to us by an individual complainant, a micro-chip company or a local vet.

The information we are processing includes your name and contact details.

Use of your personal information

We are using your personal information for the purpose of dealing with stray dogs reported to us and on the basis of public task and our legal obligation to trace the rightful owner of the dog and to return it, under the Environmental Protection Act 1990.

Who will receive or see my personal information?

Your personal information will be available to be seen by those within the Environmental Health Team for the purpose of investigating your complaint and within support services (such as the Legal, HR, Insurance and wider Finance Teams and any third party payment handler) where necessary to carry out the purpose.

We may share your name and contact details with the council's nominated kennel contractor for the purpose of returning the dog.

We may also share information with our corporate safety officer when our staff safety is viewed as being at risk. Information may also be shared with partner agencies during safeguarding investigations and for fraud identification and prevention.

Your personal information will be stored securely and will not be accessible to anyone else, including other services within the Council, unless detailed above.

Retention

All your personal information will be held by us only for as long as is necessary and then in accordance with any legal requirements imposed upon us and the Council's retention schedule. For more information please go to our website to view our [Retention schedule](#)

Transferring personal information outside of the EU

Your personal information will not be transferred outside the EU or to any international organisations by the Council. It should be noted that the Council has no control over those accessing its online public registers nor what someone does with any information they obtain from them.

Your rights

Whatever our use of your personal information you have the right of access to that personal information (this means confirmation that we are using your personal information, access to it as well as other detail) and the right to seek rectification if the information is inaccurate.

Where we are processing your personal data on the basis of public task and legal obligation you may have the right to object and the right to restrict processing.

Also, if you object to our use of your personal information and there is no overriding legitimate interest for us to continue using it or we have used your personal information unlawfully or it is no longer necessary for us to have the personal information, the right to erasure is also available to you.

Complaints
