Thank you for advising the Blackdown Hills AONB Partnership of the submission of Kilmington Neighbourhood Plan, and the invitation to comment.

Comments:

1. Overall support for the Plan.

We welcome the Plan, finding that it gives strong attention to the natural and built environment and provides a clear context for development, giving weight to the AONB landscape and referencing the AONB Management Plans and associated guidance such as the landscape character assessment throughout the supporting text and policy framework.

2. Point of clarification.

Regarding Small Scale Renewable and Low Carbon Energy Generation, on page 111 there is a reference to the Blackdown Hills AONB management plan which appears to refer to a previous version of the relevant policy. The current version is;

PD3 Support measures to improve energy efficiency and resource use and support appropriate small scale renewable energy schemes that do not detract from historic character or visual amenity, and do not conflict with the special qualities of the AONB or the conservation of natural beauty.

I would welcome any further notification of the progression of the Kilmington Neighbourhood Plan through to adoption.
