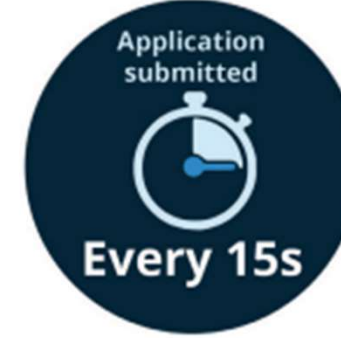

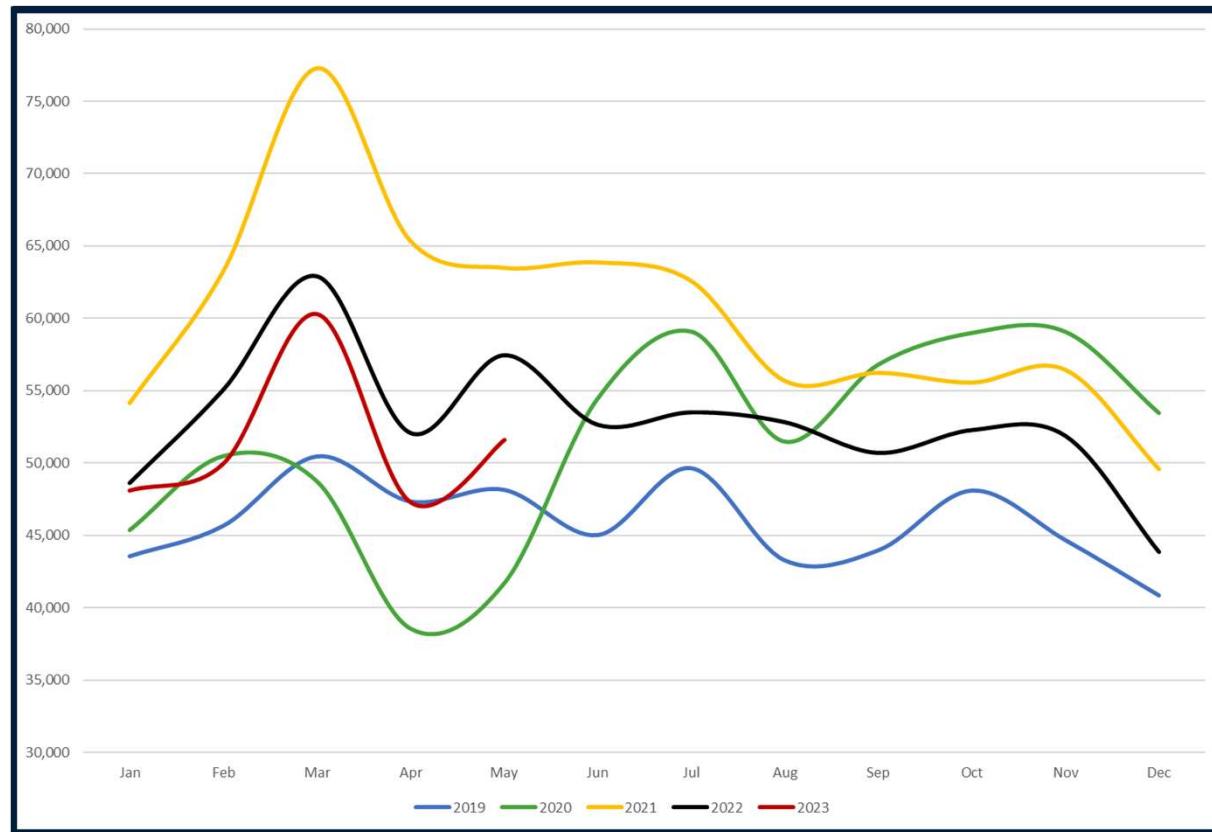

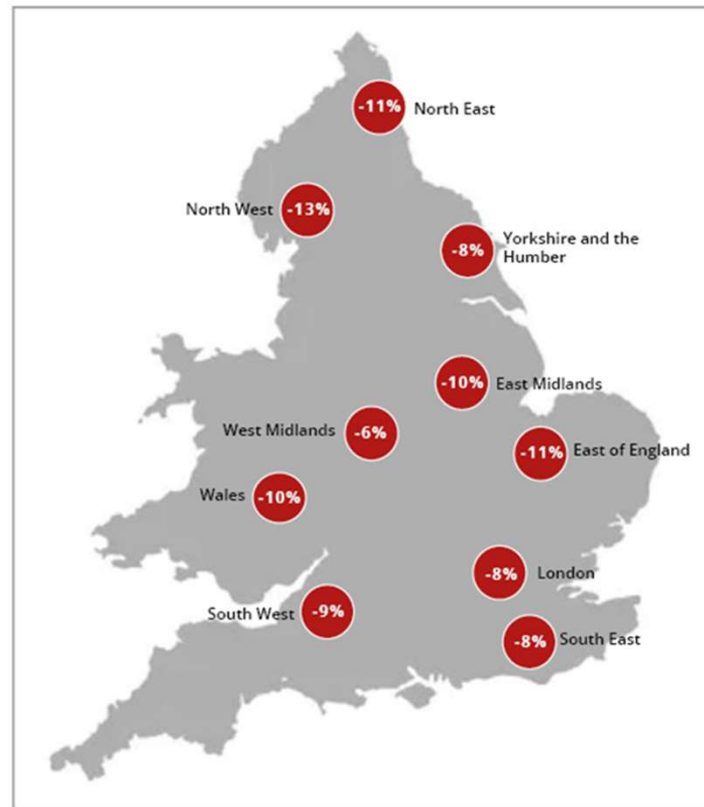


The National Application Trend



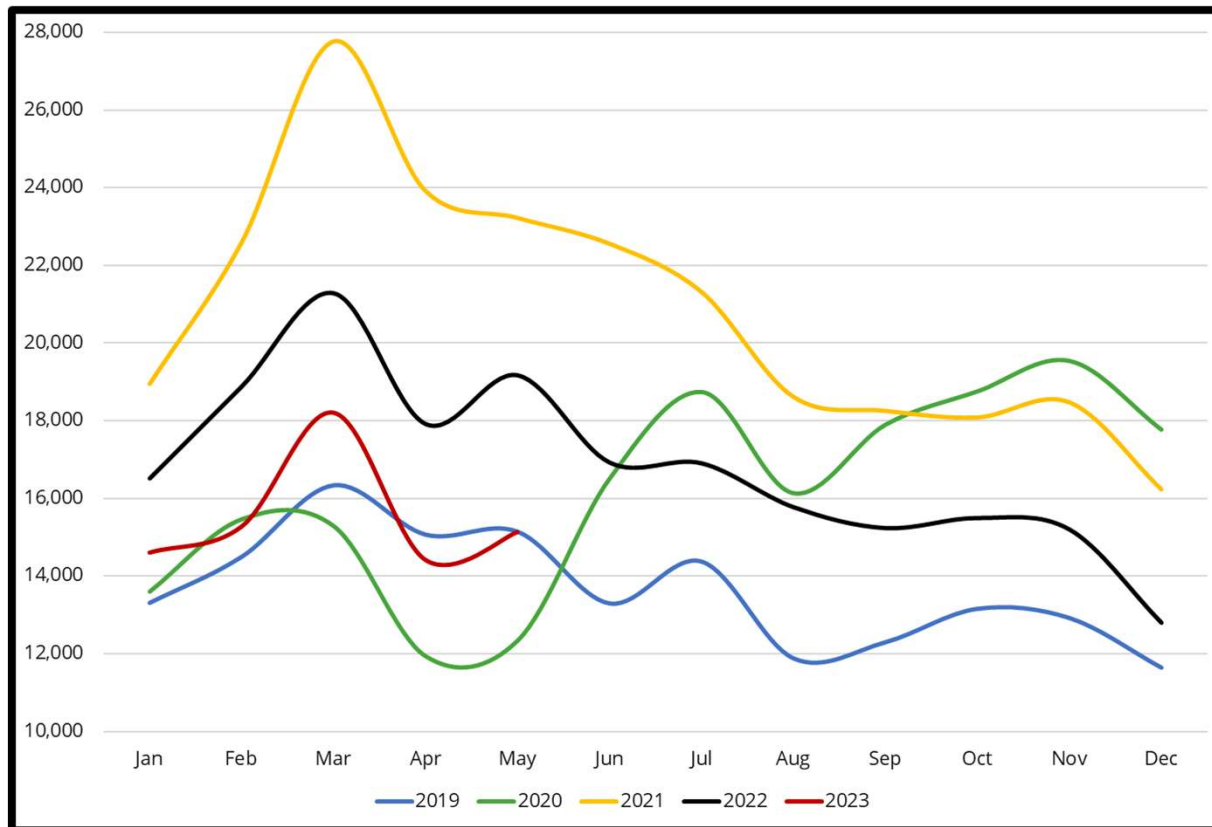


The Regional Application Trend



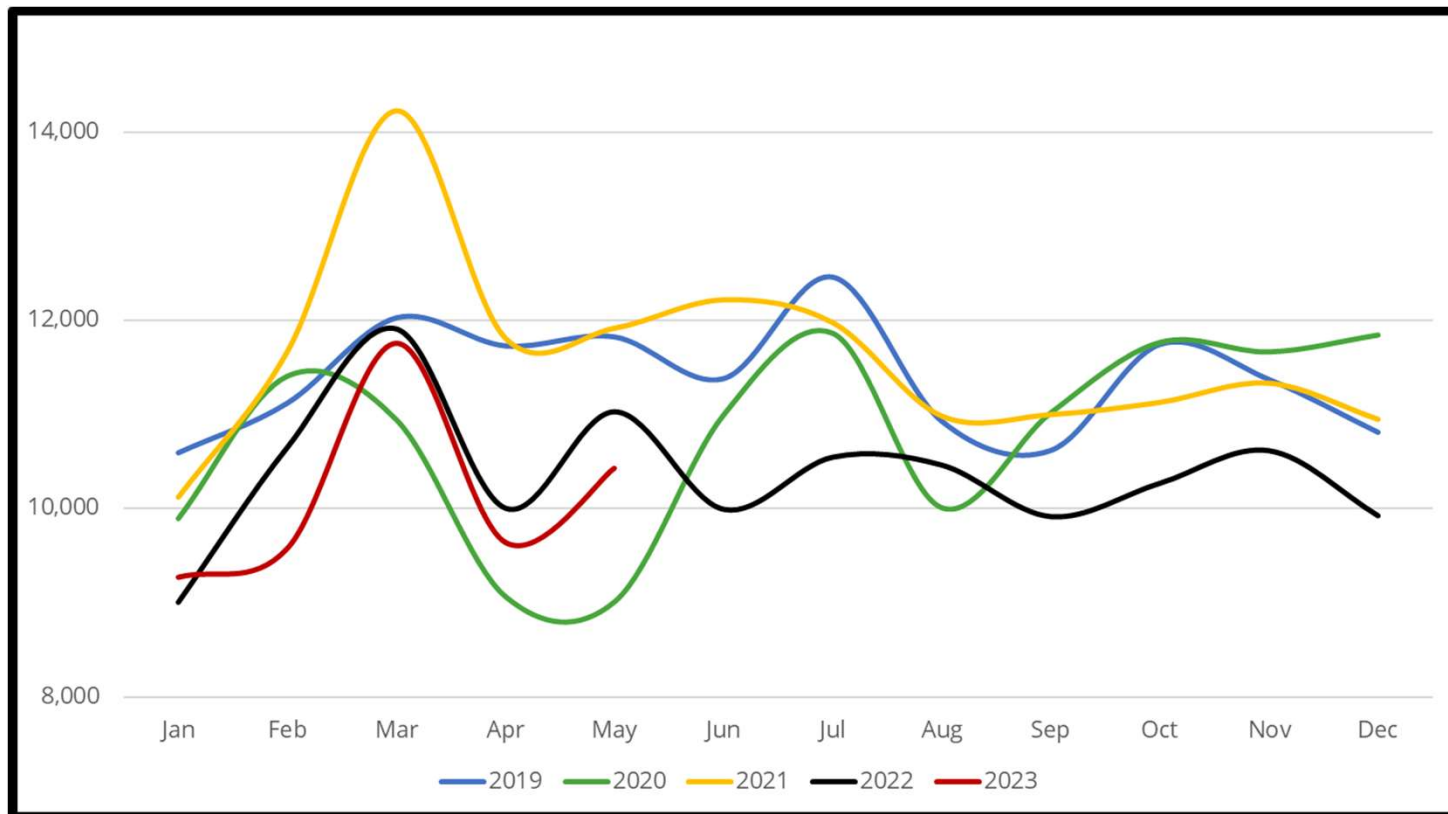

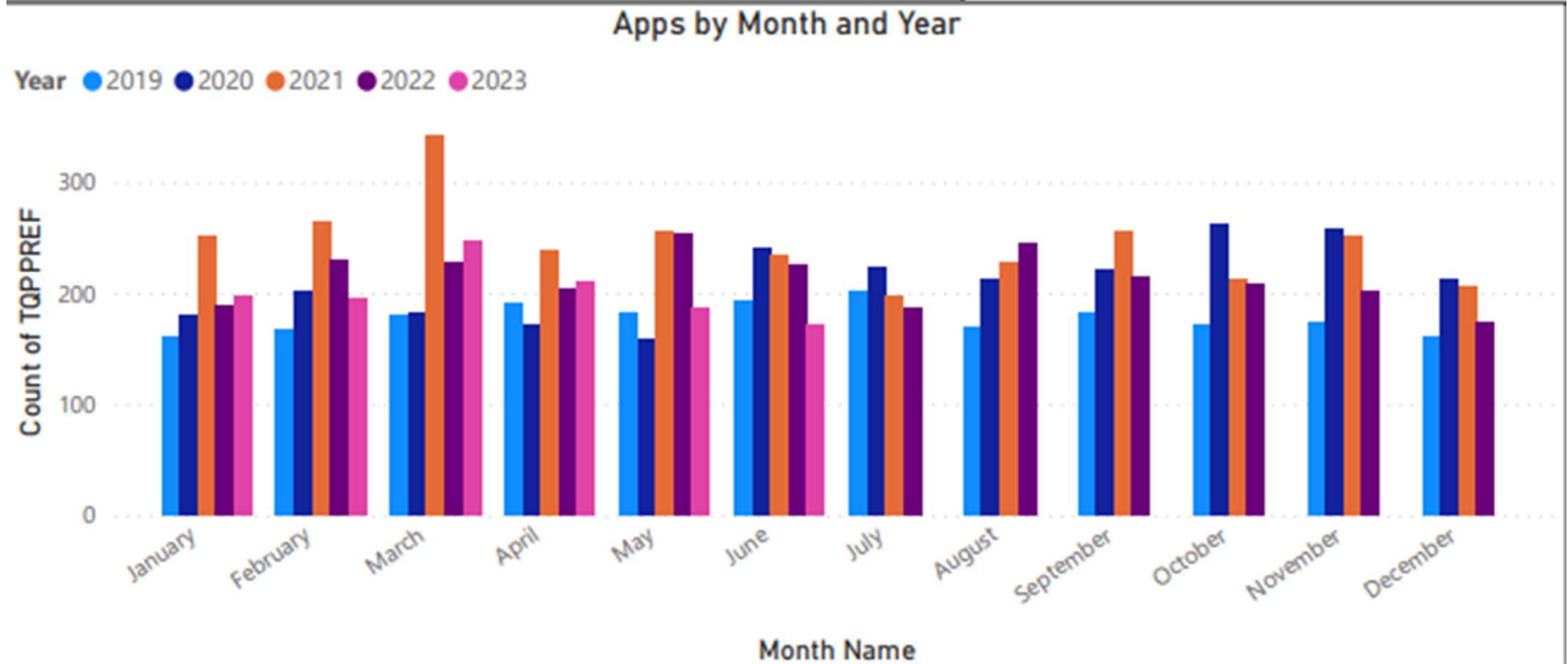

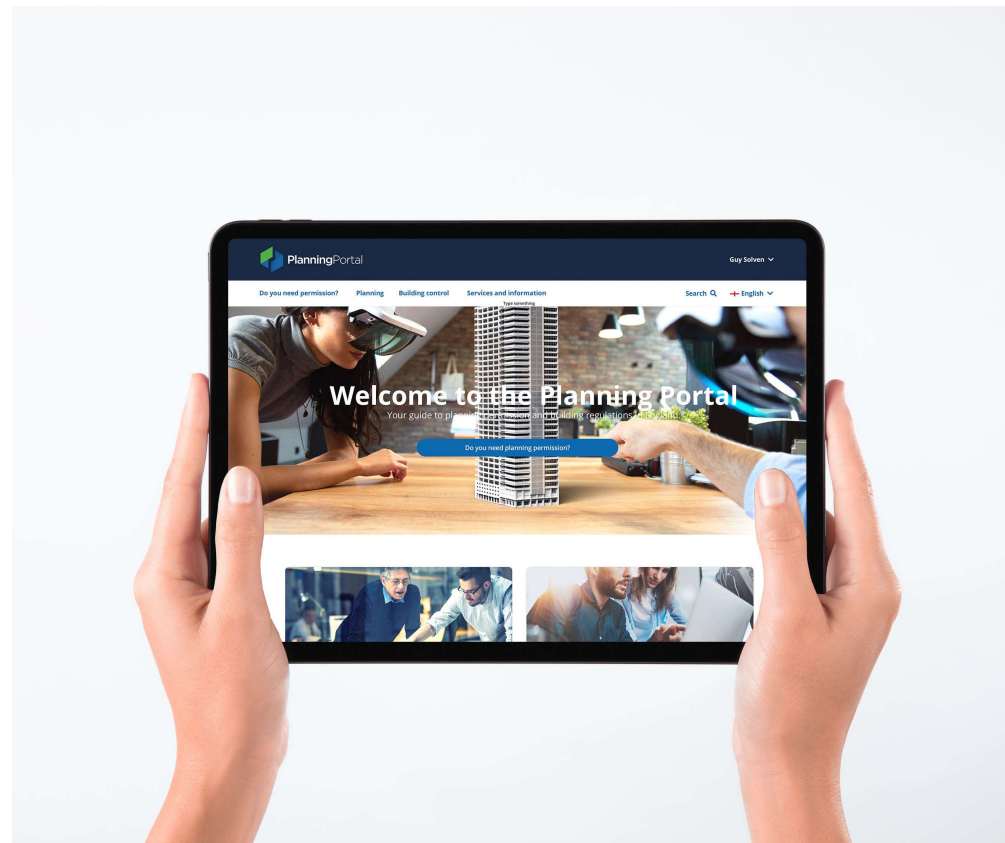

Processing and provision of planning data ©

Data	<p><u>Processing</u> Power to enable the Secretary of State to regulate the <u>processing of planning data</u> by <u>setting data standards</u> to apply to the data produced and held by planning authorities.</p> <p>This power is designed to ensure <u>data is held consistently and transmissible</u> through the planning system and can be easily reused for other purposes by third parties.</p> <p><u>Provision</u> Power to enable planning authorities to require data arising from participants in the planning system to be <u>provided digitally</u> to them, in accordance with <u>approved data standards</u>, unless it would be unreasonable to expect a particular participant to do so.</p> <p>The power is designed to ensure that local authorities are not overwhelmed by submissions in formats incompatible with data standards, resulting in <u>excessive manual re-entry</u> of data.</p>

Planning data to be made publicly available ©

Publishing	<p>Power to require planning authorities to <u>make certain planning data available</u> to the public under an approved open licence.</p> <p>This power is designed to ensure that the data held and created under the <u>data standards</u> power, is <u>openly available</u> and published for use by parties other than the planning authority and the Secretary of State. It is expected that the combination of the data standards and publication powers will result in information being provided in a <u>consistent and more visual manner</u> to the public by planning authorities.</p>

Policy paper **National Data Strategy**

3 Transforming government's use of data to drive efficiency and improve public services.

The coronavirus pandemic showed that there is massive untapped potential in the way government and public services use and share data to help and protect people. To sustain the high watermark set by the pandemic, the government will undertake an ambitious and radical transformation of its own approach, driving major improvements in the way information is efficiently managed, used and shared across government. - better relationships between communities and developments

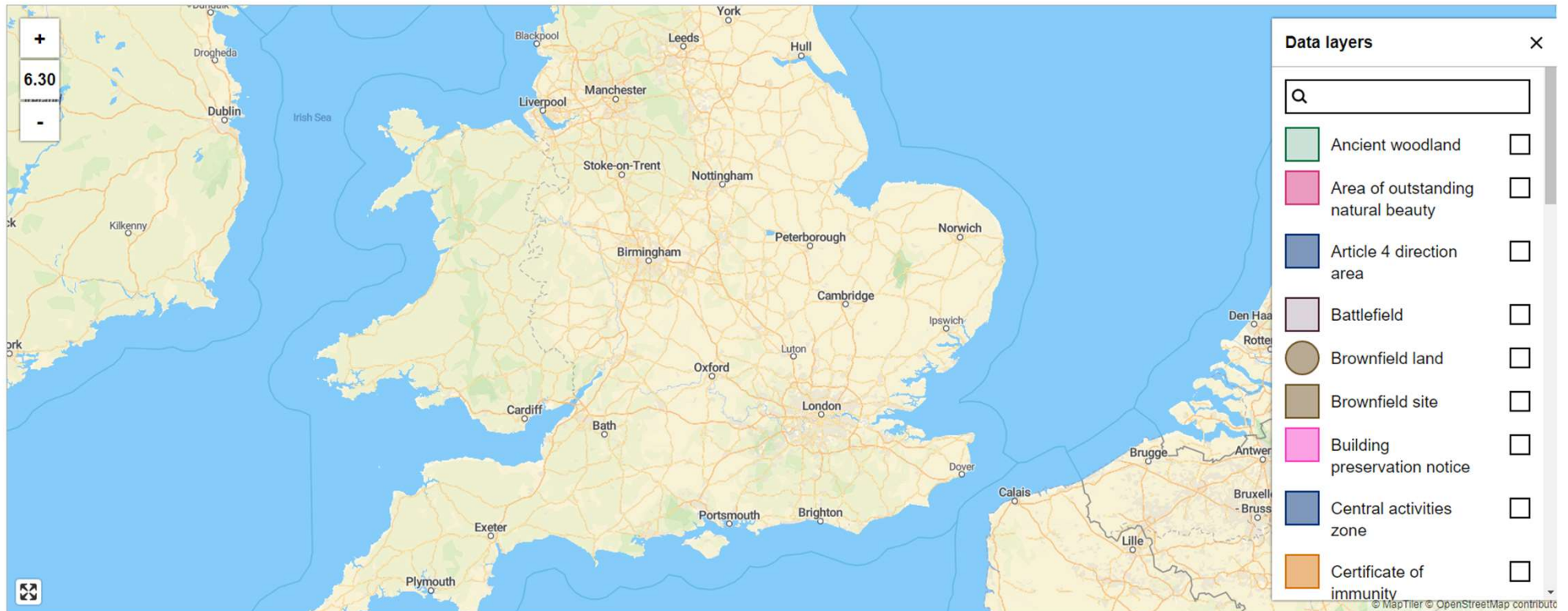

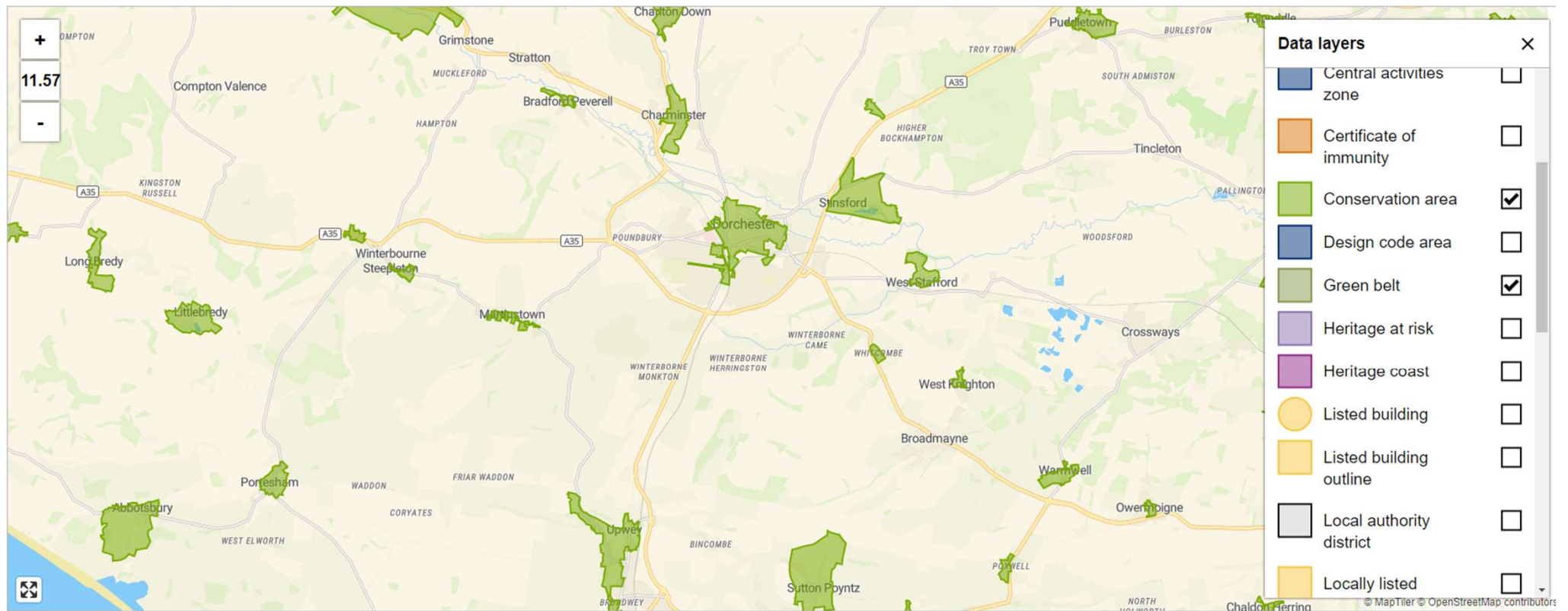

Copying Applications





Change application type when copying

- Change the application type when copying existing applications,
- Also if you want to copy over supporting documents.
- This will be a major benefit if you have incorrectly stated the application type, as you will now be able to copy existing applications instead of starting their application again from scratch.
- Incorrect application type is one of the common reasons for applications getting rejected, and this should help reduce the number of such rejections.

Give your application a name

This name is for your use but will be viewable by the Local Planning Authority if you submit the application.

Use a name that clearly identifies the proposal to you, such as the application site address e.g. 123 High Street.

What information will I need?

To create an application, you will need the following key details to start.

The site address

The site address will allow us to identify the Local Authority for your site. Once your application is complete, it will be submitted to that Local Authority.

If your site has a postcode this will be used as your site address.

However, if your site does not yet have a postcode we will help you to identify the site location.

The application type

You will need to select the application type. This will allow us to identify the information and documents you will need to provide for a successful application and determine if you will need to pay a fee.

If you are unsure of your application type, we can provide information to help you choose.

Copy Application Close

You are about to make a copy of Dorset Test.

This will create a new application for Householder planning permission with the information from this application copied over. To continue, please deselect the information you don't want copied to the new application.

Copying supporting documents includes anything that you have uploaded as part of your application. It does not include files created within the Planning Portal such as the application form PDF or the location plan. However, if you have added your own location plan file this will be included.

Site location is the address or grid reference that you identified when you created your original application.

Site boundary (if applicable) is the area of your site that you identified on a map with red/blue lines, if you chose to.

Planning is a collaborative process with numerous contributors to an application so we at the Planning Portal have developed Projects which sits at the heart of your Planning Portal account.

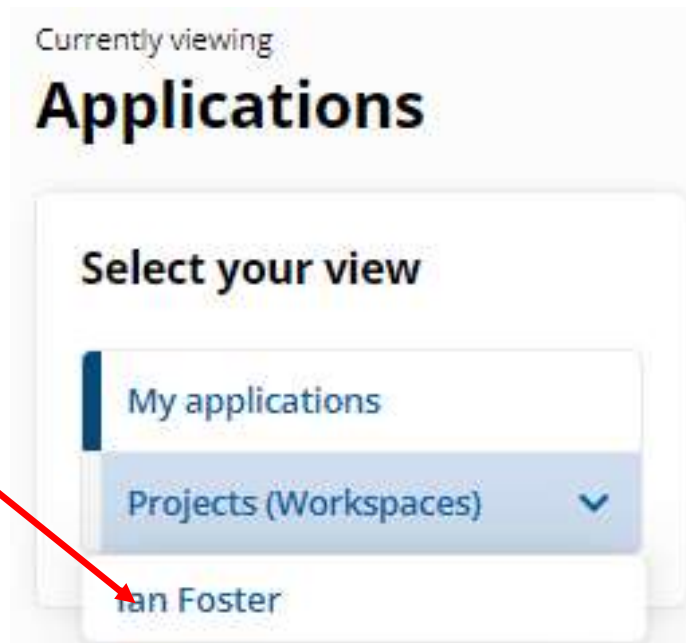

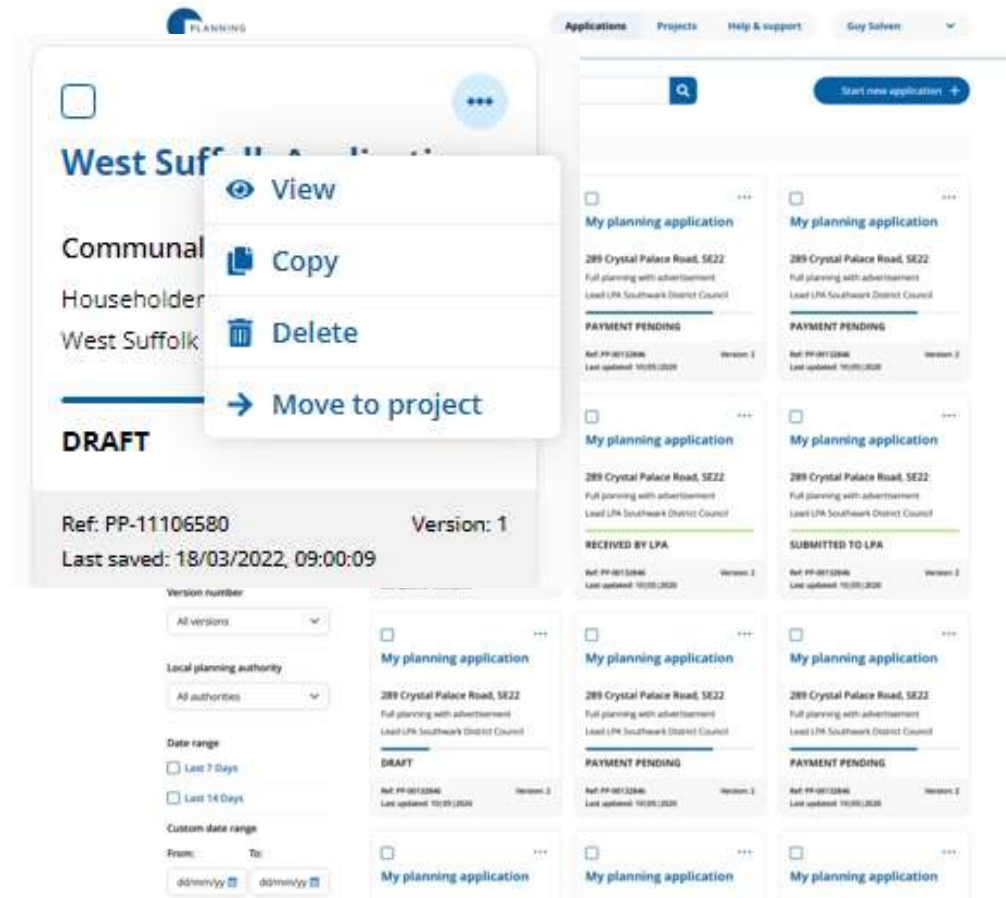

Projects on the Planning Portal

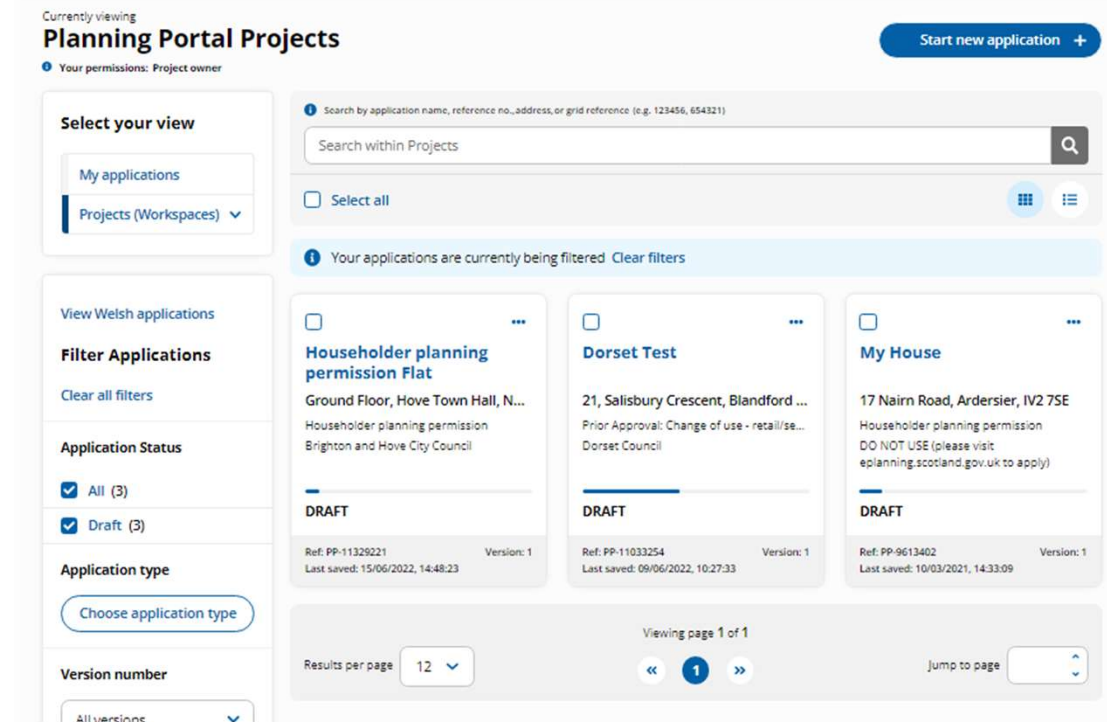
- Only you as the account holder can see and work on applications on your page

Other forthcoming changes **Coming Soon**

- Prepay Applications
 - Ability to pay or nominate at any point of the process
- Bulk Payment

- Enhanced options for payment, collaboration, Local Authority configuration, and data transfer



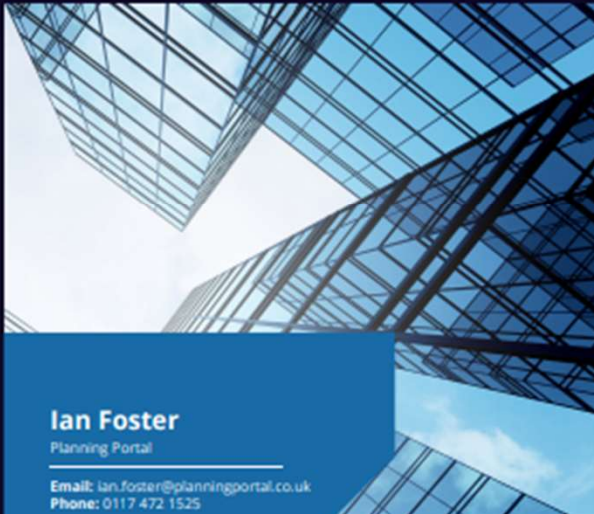
