#### Obtaining your personal information

We have been provided with your personal information by you as a respondent to our consultation on the new Draft East Devon Local Plan (2020-2040). The information that we hold will consist of your name and contact details.

The consultation process asks for information relating to your gender, locality to the area and age range but the submission of this data is optional and is used for anonymised statistical analysis purposes only.

## Use of your personal information

We are using your personal information for the purpose of consulting on the new Draft East Devon Local Plan (2020-2040) on the basis of our legal obligation to consult on the local plan under The Town and Country Planning (Local Planning) (England) Regulations 2012 (as amended) and the Planning and Compulsory Purchase Act 2004 and your consent to take part in this consultation process.

#### Who will receive or see my personal information?

Your personal information will be available to be seen by those within the relevant service and within support services (such as the Legal and Finance Teams and third party payment handler) where necessary to carry out the purpose and will be provided to the following;

Anonymised consultation responses will be published on the council's website.

Your response, in full, may be provided to the Planning Inspectorate or independent examiner, as required.

Your personal information will be stored securely within our IT system and will not be accessible to anyone else, including other services within the Council, unless detailed above or where there is a lawful reason to do so.

# Retention

All your personal information will be held by us only for as long as is necessary and then in accordance with any legal requirements imposed upon us and the Council's retention schedule. For more information please go to our website to view our <u>Retention schedule</u>.

# Transferring personal information outside of the EU

Your personal information will not be transferred outside the EU or to any international organisations by the Council. It should be noted that the Council has no control over those accessing its online public registers nor what someone does with any information they obtain from them.

## Your rights

Whatever our use of your personal information you have the right of access to that personal information (this means confirmation that we are using your personal information, access to it as well as other detail) and the right to seek rectification if the information is inaccurate.

Because we are using your information on the basis of public task and legal obligation then you also have the right to object and the right to restrict processing.

Where we process on the basis of your consent, you have the right to withdraw that consent.

Also, if you object to our use of your personal information and there is no overriding legitimate interest for us to continue using it or we have used your personal information unlawfully or it is no longer necessary for us to have the personal information, the right to erasure is also available to you.
