Obtaining your personal information

We have been provided with your personal information by you as a responder to consultation about our CIL charging schedule.

Use of your personal information

We are using your personal information for the purpose of consulting on our proposal for a CIL charging schedule and for considering your views and on the basis of public task and our legal obligation under Community Infrastructure Levy Regulations 2010 and the Town and Country Planning Act 1990 and Planning Act 2008.

Who will receive or see my personal information?

Your personal information will be available to be seen by those within the relevant service and within support services (such as the Legal and Finance Teams and third party payment handler) where necessary to carry out the purpose and will be provided to the following;

Consultation responses will be published on the council's website. This will include your name and address but contact details and signatures will be redacted.

Your response, in full, will be provided to the Planning Inspectorate or independent examiner as appropriate.

Your personal information will be stored securely within our IT system and will not be accessible to anyone else, including other services within the Council, unless detailed above.

Retention

All your personal information will be held by us only for as long as is necessary and then in accordance with any legal requirements imposed upon us and the Council's retention schedule. For more information please go to our website to view our <u>Retention schedule</u>

Transferring personal information outside of the EU

Your personal information will not be transferred outside the EU or to any international organisations by the Council. It should be noted that the Council has no control over those accessing its online public registers nor what someone does with any information they obtain from them.

Your rights

Whatever our use of your personal information you have the right of access to that personal information (this means confirmation that we are using your personal information, access to it as well as other detail) and the right to seek rectification if the information is inaccurate.

Because we are using your information on the basis of public task and legal obligation then you also have the right to object and the right to restrict processing.

Also, if you object to our use of your personal information and there is no overriding legitimate interest for us to continue using it or we have used your personal information unlawfully or it is no longer necessary for us to have the personal information, the right to erasure is also available to you.
