Use of your personal information

We are using your personal information for the purpose of delivering a clinical waste collection service and on the basis of our legal obligation and public task to provide waste collection services under the Environmental Protection Act 1990 and The Waste (England and Wales) (Amendment) Regulations 2012. The information that we hold may include your name, address and contact details.

We will also hold eligibility information which will include detail about the type of waste to be collected. This may include special category data relating to health conditions. This data will only be processed with your consent. You are not obliged to provide us with specific information relating to medical conditions in order to receive the service.

Your personal information will be used to ensure you receive the correct service.

Who will receive or see my personal information?

Your personal information will be available to be seen by those within the StreetScene service and will be shared with our recycling and waste collection contractor service and within support services (such as the Legal and Finance Teams and third party payment handler) where necessary to carry out the purpose

Eligibility information will not be shared with any third party, including our waste collection contractor.

We may also share information with our corporate safety officer when our staff safety is viewed as being at risk. Information may also be shared with partner agencies during safeguarding investigations and for fraud identification and prevention.

Your personal information will be stored securely and will not be accessible to anyone else, including other services within the Council, unless detailed above.

Retention

All your personal information will be held by us only for as long as is necessary and then in accordance with any legal requirements imposed upon us and the Council's retention schedule. For more information please go to our website to view our [Retention schedule](#)

Transferring personal information outside of the EU

Your personal information will not be transferred outside the EU or to any international organisations by the Council. It should be noted that the Council has no control over those

accessing its online public registers nor what someone does with any information they obtain from them.

Your rights

Whatever our use of your personal information you have the right of access to that personal information (this means confirmation that we are using your personal information, access to it as well as other detail) and the right to seek rectification if the information is inaccurate.

Because we are using your information on the basis of our legal obligation to provide a waste collection service and in carrying out a public task to collect recycling then you also have the right to object and restrict processing.

Also, if you object to our use of your personal information and there is no overriding legitimate interest for us to continue using it or we have used your personal information unlawfully or it is no longer necessary for us to have the personal information, the right to erasure is also available to you.

Complaints
